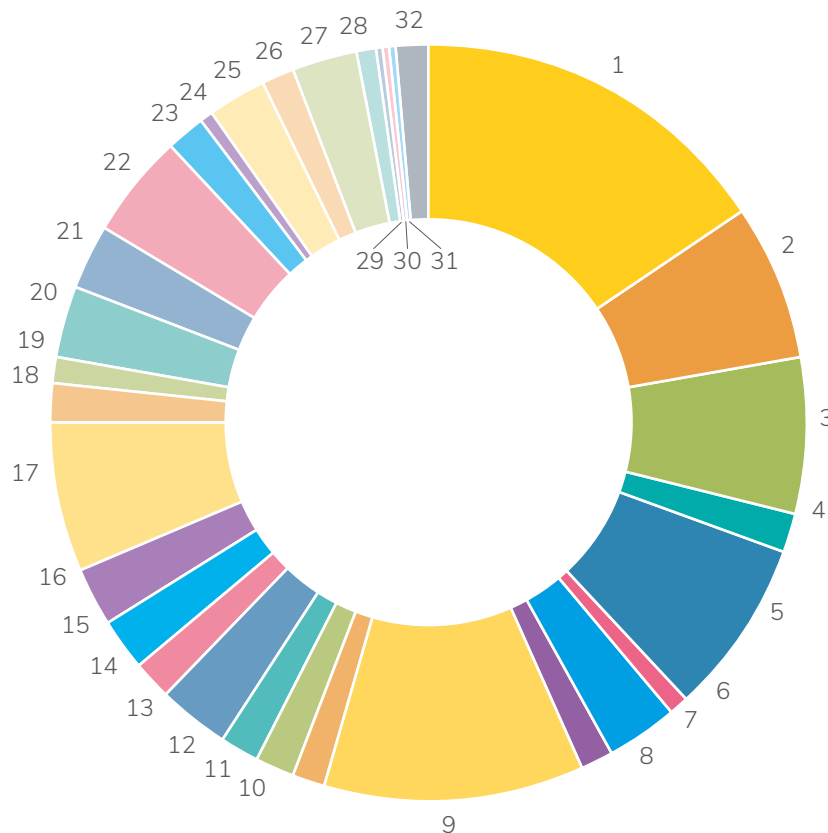

PruFund Growth Fund

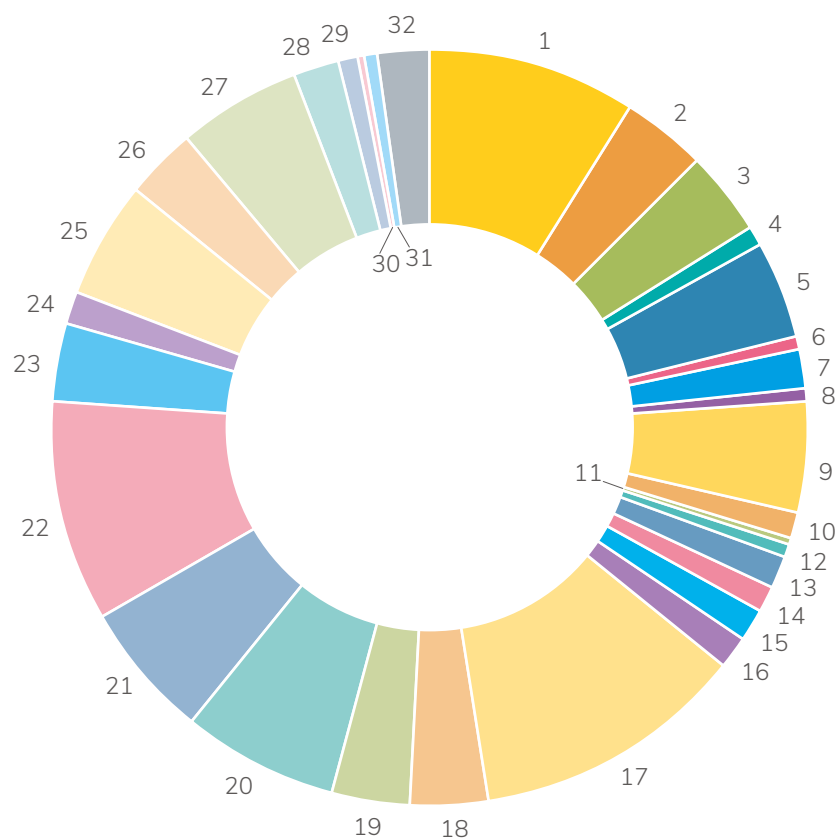
